Eva Egron-Polak

ABSTRACT

Learning from the past several decades of internationalization, assessing and analyzing the present and critically considering what the future may hold for higher education institutions, the presentation will discuss some of the key issues and factors that HEIs are, or will be facing, when designing their internationalization strategies and activities. Noting that the past, present and future are experienced differently by individuals, institutions, countries and regions, the presentation will stress how values and principles may be helpful for navigating a deeply complex and changing era.

EVA EGRON-POLAK BIO



A Czech-born Canadian, Eva Egron-Polak studied in Canada and France. From 2002 to 2017 she was Secretary General of the International Association of Universities (IAU). Previously, she held various positions at Universities Canada, including as Vice President, International. She has and continues to serve on many Boards and International Advisory Committees of organizations such as the Magna Charta Observatory, the Global Centre for Higher Education, StudyPortals, the European University Institute, the ARQUS European University Alliance and Queen's University (CA). She has consulted for the OECD, the European Commission, the World Bank and UNESCO and has undertaken reviews of higher education in many countries including in Spain, Egypt and Romania. Eva Egron-Polak initiated and co-authored the IAU Global Survey Reports on Internationalization of Higher Education (2010 and 2014), participated in the study on Internationalization of Higher Education for the EU Parliament (2015) and launched the IAU service to assist universities in developing their internationalization strategy. She served on the drafting group of the 2020 Magna Charta Universitatum and published many book chapters on various higher education topics. She is the recipient of the Palmes academique from the Government of France and holds a Doctorate honoris causa from Mykolas Romeris University, Lithuania and McMaster University, Canada.

Changing higher education environment and university internationalization in East Asia: gap between policy and practice

Hiroshi Ota

ABSTRACT

The higher education environment in East Asia is undergoing significant changes due to COVID-19, geopolitical risks, and demographic issues. These issues also had a considerable impact on the internationalization of universities. Higher education and its internationalization in East Asian countries, such as Japan, Korea, China, and Taiwan, have been driven by government initiatives. Governments in these countries have positioned the internationalization of higher education, especially in attracting international students, as a high-level policy and have launched a series of measures. However, these policies often do not carefully consider the situation and reality at universities. In addition, their internationalization policies are not well coordinated with higher education policies as a whole. Thus, these problems have led to unexpected (and sometimes expected) consequences, showing gaps between government policies and university practice. My presentation will attempt to analyze these issues from multiple perspectives.

HIROSHI OTA BIO



Dr. Hiroshi Ota is a Professor at the Center for General Education at Hitotsubashi University, Tokyo, where he serves as Director of the university's Global Education Program. Currently, he is a Visiting Scholar at Yenching Institute, Harvard University.

His research primarily focuses on higher education policies and practices related to internationalization and international student mobility from a comparative perspective. He has more than 150 publications in Japanese and English, including 20 book chapters published by Springer, Routledge, SAGE, Multilingual Matters, and so on. Dr. Ota serves as a vice president of the Japan Association of International Student Education (JAISE) and a board member of the Research Consortium for the Sustainable Promotion of International Education (RECSIE). In addition, he is a visiting scholar for the Japan Student Services Organization (JASSO), a government agency that supports and promotes international education. Dr. Ota received his Ed.M. and Ph.D. from the State University of New York at Buffalo. He was also awarded a Fulbright Scholarship.

Transforming European higher education: the role of the European Universities initiative

ABSTRACT

The European Universities alliances are a flagship initiative of the European strategy for universities, creating strong partnerships between higher education institutions from all across Europe. 50 alliances have now been approved, involving more than 430 HEIs in 35 countries. The aim is to develop long-term structural, strategic and sustainable cooperation between the HEIs involved for the benefit of their students, staff and society, to improve the international competitiveness of HEIs in Europe and promote European values and identity. Faced with these great expectations, and 4 years after the first 17 alliances started their work, is this potential being achieved? What is it like for those HEIs that are part of an alliance? In this session we will take a look at the initiative from the inside and analyse the progress made as well as the challenges encountered.

Laura Howard has over 25 years' experience in international relations and has published and presented at international conferences extensively on many issues related to international higher education.

She has held various management positions at the University of Cadiz (Spain) where she lectures on language acquisition and is currently General Director of the European University of the Seas (SEA-EU), a European University Alliance.

On a national level, she chaired the Commission for International Promotion created within the International Relations Commission of the Spanish Rectors' Conference from 2008 until 2010 and was part of the initial advisory committee to Universidad.es, a public-sector foundation for the international promotion of Spanish universities. Laura served as President (2014-2016) of the European Association for International Education (EAIE) and was Vice-President of the Compostela Group of Universities from 2007 to 2015. Strategic importance of global engagement and internationalisation of UK universities – joint work between the UK Higher Education Sector and the UK Government

ABSTRACT

Global engagement lies at the heart of what makes UK universities special. There are many reasons why the UK remains the world leader and an attractive study destination for international students. This session will look at the UK and how the UK higher education sector works successfully with the wider government's export agenda. We will also focus on Transnational Education (TNE) efforts that have been embraced by UK Universities for a long time and how the UK government supports these. In 2020/21 approximately 80% of the sector reported students studying through TNE, more than ever before. During that period, just over half a million of students were studying on UK TNE programmes abroad, making TNE a strategic activity for many providers in the UK.

Renée Zicman Executive Brazilian Director of the is Association for International Education (FAUBAI), which brings 220 higher education institutions members. She has been Professor in the School of Social Sciences (1980-2017) and Director for International Affairs (1994-2012) at the Pontifical Catholic University of São Paulo (PUC-SP). She has been co-founder of the Latin American Initiative for the Internationalization of Higher Education (INILAT), a space for dialogue and exchange between associations and networks from Argentina, Brazil, Chile, Colombia, Mexico and Peru. Professor Zicman developed many national, regional and international activities being involved in a variety of programs and projects in the field of internationalization of higher education. She has participated as a panelist in several international events. She has published books and articles on Internationalization of Higher Education, including a chapter at The Bloomsbury Handbook of The Internationalization of Higher Education in The Global South. She is member of the editorial board of the peer-reviewed journal Internationalization of Higher Education. She has been appointed Knight of the Order of the Legion of Honor, the highest French decoration, and she is the recipient of the Order of Academic Palms from the Government of France (Knight and Officer).

Rachel Wellam is the Senior Manager, Global Student Mobility at Monash University, a position she has held since 2016. With over 20 years of experience in international education, she has developed a strong passion and focus for learning abroad. On this topic, she has actively contributed to national discussions and has been a prolific presenter at both national and international conferences, including the Forum on Education Abroad, NAFSA, EAIE and APAIE. In addition, she has collaborated on the publication of journal articles, most recently in 2019 with the article titled 'Interfaculty Collaboration for Improving International Mobility Experiences: Sustaining a Dialogue Across Difference.' Rachel holds Bachelor of Arts and Bachelor of Commerce degrees, both earned at the University of Melbourne.

This session shares insights and lessons learned from Monash University's experience in the region, drawing on our extensive regional presence within the context of this growth. Addressing the diverse challenges of responsible internationalisation, while a continuous learning process, is leading to the development of new models and capabilities for education abroad within the institution. These approaches are not only relevant within a regional context but may offer new perspectives and adaptable solutions across a wider array of settings and partnerships.
